Please be informed that AREIT, Inc. (AREIT) received today the Securities and Exchange Commission's (SEC) approval of its property-for-share swap with Ayala Land, Inc. (ALI), Accendo Commercial Corp. (Accendo), and Cagayan de Oro Gateway Corp.
